The uptick in ridership was due to the client base receiving covid vaccinations and a declining number of covid-19 cases in our service area. Our ridership total for the fiscal year 2021 was 158,508 rides. This is an increase of 14,710 rides. CTWSI's mileage was increased as well; we drove 536,864 miles compared to 496,525 miles from fiscal year 2020. CTWSI's rides performed were for senior citizens/persons with disabilities to congregate and/or home delivered meals, youth to and from school or summer recreation activities, general public to and from employment, all ages to and from medical appointments, as well as shopping and social recreation.
